 - Highlight: sessions from the Positive Coaching Alliance for athletes and parents; Tony does not receive any money from the School Board for Professional Development so this will hopefully meet those needs

 - O DISCUSSION:
 - Dana Hartup: this is a good thing, WBL provided this training and it was well-received
 - Larry Cahill: we need the coaches to dress better for the banquets, and act like they want to be there, and act like the kids mean something to you.
 - Gina this is a good approach to how we can work on making this better; they get that culture is about everybody: coaches, parents, staff, athletes. This is a positive attempt to make our culture better
